

KOMBAT TAEKWONDO LTD. ACCOUNT TERMS AND CONDITIONS

1. Acceptance of Terms

By creating an account with Kombat Taekwondo LTD., you agree to be bound by these Terms and Conditions, as well as our Privacy Policy. If you do not agree to these terms, you may not create an account or access our services.

2. Eligibility

To create an account, you must be at least 18 years old or have parental/guardian consent if under 18. You must provide accurate and complete information and keep your account details updated. Kombat Taekwondo LTD. reserves the right to verify the eligibility of any user at any time.

3. Account Registration, Security & Verification

Account Verification Requirement

Kombat Taekwondo LTD. may require users to verify their identity before granting access to services. Failure to complete verification may result in account suspension.
